

The MIRCE Akademy Fellowship Protocol

Article 10:

“The Akademy shall, at its discretion, award the Fellowship of the MIRCE Akademy to recognise individuals who have made a significant contribution to the MIRCE Science. The President shall confer the title of Fellow to nominated individuals at the functions approved for this purpose. “

The Constitution of the MIRCE Akademy, 25th May 1999.

1. No restrictions based on gender, race, colour, nationality, religious or political conviction shall be imposed upon any individual associated with Fellowship award.
2. The Akademy recognises the skill and the knowledge of individuals who have made a unique contribution to MIRCE Science or Methods at a global level of significance by awarding the **Grand Fellowship** of the **MIRCE Akademy**. The recipient is entitled to use the full designation of the award or the abbreviation **G.F.M.A.** This is the highest award that the Akademy can bestow upon an individual.
3. The Akademy recognises the capability and knowledge of individuals in MIRCE Science or Methods by awarding the **Science Fellowship** of the **MIRCE Akademy**. The recipient is entitled to use the full designation of the award or the abbreviation **S.F.M.A.**
4. The Akademy recognises the contributions of individuals to MIRCE Akademy or Science by awarding the **Honorary Fellowship** of the **MIRCE Akademy**. The recipient is entitled to use the full designation of the award or the abbreviation **H.F.M.A.**
5. The President of the Akademy shall inform the nominee in writing about the award of the Fellowship.
6. The nominee shall accept the Fellowship by replying in writing to the President within 30 days from receiving the notification of the award.
7. The nominee is expected to complete the Fellow Profile Form prior the Award.
8. The President shall confer the title of Fellow to the nominee at the functions approved for this purpose.
9. No financial liability shall be incurred or attributed to the parties in connection with the Fellowship award unless otherwise agreed in a subsequent and separate arrangement.

10. The Fellowship shall be awarded for an indefinite period of time. It may be terminated by either party, the Fellow or the Akademy, in writing. The President, will dissolve the Fellowship without prejudice within three-months of receiving or giving notification.
11. The Fellow and the Akademy shall promote their association with respect and dignity.
12. Fellows of the MIRCE Akademy maintain the highest standards of excellence in MIRCE Science and have the following privileges:
 - i) To associate themselves with the Akademy as a global centre of excellence,
 - ii) To have access to leading experts in the field of MIRCE Science,
 - iii) To work with the Akademy to solve problems, undertake research etc.,
 - iv) To have access and use of the Akademy's Resource Centre,
 - v) To have priority booking for all events organised by the Akademy,
 - vi) To publish papers, monographs and books in conjunction with the Akademy,
 - vii) To contribute to the Akademy's Diploma Programmes as visiting experts, tutors and mentors for students,
 - viii) To contribute to the Akademy's Centre of MIRCE Science as visiting experts, mentors for students or adviser to research projects undertaken,
 - ix) To contribute to the Akademy's Laboratory for MIRCE Methods as visiting researcher, consultant or advisor,
 - x) To be elected as a member of the Council of Fellows,
 - xi) To organise study visits and to make technical presentations, demonstrations, etc.,
 - xii) To participate in all activities of the Akademy's Annual International Symposium.
13. Fellows of the Akademy may benefit from other rights and privileges that might be, from time to time, granted by the MIRCE Akademy.
